Illinois FFA Alumni Council Nomination Guidelines

- ◆ An Intent to run for Illinois FFA Alumni Council must be submitted to the Illinois FFA Center with a postmark no later than October 1st – NO EXCEPTIONS.
 - ◆ The Intent to run for Illinois FFA Alumni Council must be completed in full for consideration.
 - ◆ The Intent to run for Illinois FFA Alumni Council should indicate each office of interest
 - 1 year terms: President (Must have served on the Alumni Council for 2 yrs min.)
 - Vice President
 - Treasurer
 - Secretary
 - Reporter
- *Duties and responsibilities of each office are available at the Illinois FFA Center
- ◆ Intents will be announced and the biography portion presented in the newsletter prior to the annual meeting and will be presented as the ballot of officers at the Illinois FFA Alumni Annual Meeting in January. No additions will be added to the ballot of officers, unless approved by the Illinois FFA Alumni Council.
 - ◆ The biography portion of the Intent to run for Illinois FFA Alumni Council will be printed in the state newsletter and the entire form will be put on the Illinois FFA Alumni web page and be made available for members to review at the annual meeting.

- ◆ District Directors will still be elected during the District Caucuses at the Illinois FFA Alumni Annual Meeting. The Directors need not complete an Intent form but can fill one out if they wish.
